3,894 expelled on second day of SSC exams

Expulsion and arrests marked the second day of the Secondary School Certificate (SSC) examinations 1990 across the country on Saturday.

Thirty teachers were also suspended for aiding the examinees.

A total of 3,894 candidates were expelled under all the four education boards—Dhaka, Comilla, Rajshahi and Jessor on the day for adopting unfair means in the English first and second paper examinations. This brings the total number of can-

didates expelled to 8,454 during the last two days.

A total of 18 invigilators were also expelled and 27 outsiders were arrested from different centres for supplying copies and helping the examinees adopt unfairmeans.

Barring some minor incidents, examinations on Saturday, were by and large peaceful.

One thousand 447 candidates were expelled from Dhaka Board, 608 from Comilla Board, 1,736 from Rajshahi Board and 101 from Jessor Board for adopting unfairmeans.

The eighteen invigilators expelled for supplying copies were: one from Narsingdi, five from Faridpur, one from Gopalganj, five from Jamalpur and six from Rajshahi. Twenty-seven outsiders were arrested from different examination centres.

A report from Manikganj adds: Four invigilators at Shibalaya centre were suspended for allegedly aiding candidates during examination. Police arrested three people from Sadar upazila centre for aiding candidates. Officials said, 63 candidates were expelled in the district.

Our Correspondent from Mymensingh reports: 119 candidates were expelled for copying and three invigilators suspend-

ed for aiding students in copying during examination from different centres the district on Saturday.

Our Correspondent from Pabna reports: 127 candidates were expelled from nine centres of the district for adopting unfairmeans in English examinations on Saturday. The highest 56 candidates were expelled from Shathiya centre.

Our Correspondent from Rajshahi reports: A total of 1,736 examinees were expelled in different centres under Rajshahi Board for adoption of unfairmeans on Saturday.

Four invigilators were also expelled for helping students during the examinations. They are two from Mohanpur and two from Sujanagar.

Our Khulna Correspondent reports: 58 candidates were expelled for adoption of unfairmeans in the English examinations in different centres of Khulna.

Our Correspondent from Gazipur reports: 65 candidates were expelled on the second day of the SSC examinations from five centres under five upazilas of the district. Of them, three were expelled from Cantonment Board, 29 from Kapasia, 10 from Kaliakoir, 21 from Sripur and two from Kaliganj.

Seven invigilators were also expelled for their involvement in supplying copies to the examinees.

Our Correspondent from Dinajpur reports: 169 candidates and four invigilators were expelled in 13 upazilas of Dinajpur and five upazilas of Thakurgaon districts on Saturday. Eight outsiders were also arrested for supplying copies.

Our Correspondent from Gopalganj reports: 124 examinees were expelled in five upazilas of the district for adoption of unfairmeans in the English examinations on Saturday. Invigilator Maulana M. Habibur Rahman was expelled for helping adoption of unfairmeans in Mokshedpur centre on the day.

Our Correspondent from Mymensingh reports: 299 examinees were expelled in different centres for adoption of unfairmeans and two invigilators were expelled for helping the candidates. Two outsiders were also arrested.
