2. ELIGIBILITY :

a. Age as on 15 February 1982 (Affidavit NOT acceptable).

— Between 21-28 years
For freedom fighters|Service personnel, it is 21-30 years.

b. Marital Status.

— Married|Un-married.

c. Citizenship.

— Must be a permanent citizen of Bangladesh.

d. Sex.

— Male.

e. Physical Standard.

— Height 5'—4" (Minimum).

f. Educational Qualification :—

(1) For Army Education Corps.

— M.A|M.Sc. Second Class with Honours (Second Class) in Bengali, Chemistry (Physical—Inorganic), Economics, International Affairs and Mathematics from any recognised University|College.

(2) Judge Advocate.

— LLB|B. Jur (Hons), M.Jur|LLB. (Hons)|LLM. Preference will be given to those who are actually practising law.

3. Candidates during interview will produce the following items to the President of Preliminary Selection Board :—

a. Application in plain paper mentioning the Corps|Department in which he is interested to join. Govt. Servants should apply through proper channel.

b. Three copies of recent passport size photographs duly attested by a Gazetted Officer|Commissioned Officer.

c. Original Certificates of Matric|SSC.

d. Degree Certificates as applicable

e. Two copies of character certificates from the Head of the Educational Institution last attended mentioning Educational qualifications.

f. No TA|DA will be admissible to the candidates for preliminary selection.

4. Candidates declared medically unfit by an Appeal Medical Board are not eligible (However, a candidate declared unfit by an ordinary Medical Board can apply).

5. Candidates selected by Preliminary Selection Board will be given prescribed forms to fill up which they will send along with postal order|Bank Draft for Tk. 15.00 (Not refundable) in favour of AG's Branch, PA Directorate (PA—2), Army Headquarters, Dacca Cantonment by 15 March, 1982.

6. Candidates will be medically examined by a Medical Board for which intimation will be given later on. Those declared medically fit will be called before Final Selection Board at Army Headquarters.

7. Candidates finally selected will undergo post-commission training at nominated training institution. On successful completion of 12 weeks training they will join respective Corps|Department.
