Benefits at a glance

The President and Chief Martial Law Administrator, Lt Gen. H.M. Ershad on Saturday announced a 18-point measures for Government and non-government college, school and madrasa teachers to solve their problems, reports BSS.

The measures announced by President Ershad include: (1) Taka one hundred per month as house rent allowance for non-government college, school and madrasa teachers;

(2) Second class gazetted status in respect of travelling and daily allowances for the trained graduate teachers;

(3) Fifty per cent of appointments of teachers in the scale of 625-1,315 in Government schools will be filled up through promotions of the meritorious teachers;

(4) Steps will be taken for appointment of eligible demonstrators in the pay scale of 625-1,315 as lecturer in the Government colleges;

(5) Eighty per cent of the post of professors, associate professor and assistant professor in Government colleges will be filled up through promotions. As a result of this step 2,000 teachers will be promoted soon;

(6) Financial grant equivalent to one yearly increment will be given to the non-government teachers with effect from January 1 this year;

(7) The experience of the teachers in the non-government educational institutions will be counted from the date the institution concerned received recognition from proper authorities.

(8) The ratio of lecturers and assistant professors have been made 6:3 from 5:2 as a result, most of the lecturers will be able to enjoy 1,400-2,223 pay scale after completing eight years of service;

(9) Eligible teachers of non-government educational institutions will be appointed on deputation as per 20 per cent rule.

(10) If any person with second class honours and master degree was a school teacher and later appointed as college teacher, his service length will be determined by adding his experience in the school with that of the college;

(11) Break of service upto six months will be treated as continuity of service in case of the teachers of non-government educational institutions when they get appointment from one institution to the other;

(12) The matter of exemption of income-tax of the non-government teachers has been sent to the National Revenue Board for consideration.

(13) Government pay scale will be introduced for class three and four employees of non-government educational institutions. Similarly appropriate pay scale will be introduced for the "Kabiyatirtha" teachers;

(14) If any educational institution is functioning on the vested and abandoned lands and if that land is not required for any important programme of the Government then that land may be allotted in favour of the concerned institution as per law if it is found logical;

(15) The "Iftedayee" class of teachers attached with Dhakhil Madrasas will be given necessary grants as per Government pay scale;

(16) Directives have already been given to appoint subject-wise lecturers in the madrasas;

(17) The "head muhaddesh" of Kamel Madrasas will be given the status of an assistant professor of government college;

(18) The allowance for the karris of Forkania Madrasas will be restored with immediate effect. Introduction of time scale for teachers in Government educational institutions will be effective from January 1984.
