RAJSHAHI.

This is being notified for the information of all concerned that the Secondary School Certificate Examination of 1982 of the Board of Intermediate and Secondary Education, Rajshahi, shall be held on Thursday 11 March 1982. The last dates for the submission of application forms for the said examination, alongwith the required examination fees, to this Board by the Regular, Retained, Divisional Development and Irregular candidates are :-

1. (a) The last date for the submission of Examination Application Form and Fees without Late Fees is 14-12-1981.
(b) The last date for the submission of Examination Application Form and Fees including Late Fees of Tk. 15.00 (fifteen) is 24-12-1981.
(c) The last date for the change of Centre is 16-1-1982.
2. The school authorities must complete the selection test of the students in their respective schools by 21-11-1981 and collect all fees from the examinees selected and fill in the Examination Forms and submit the same, alongwith the Registration Numbers, to this Board within the aforementioned dates.
3. Retained Examinees :- Retained Candidates who were registered for the academic year 1977/78 or later should put the same Registration Number in the Examination Forms. Those who registered for a date earlier than the aforesaid academic year must take the Examination as Regular candidates and the registration must be renewed and the relevant form is to be filled in for registration and the same alongwith a forwarding letter and a Bank Draft, must be sent to the Secretary of this Board under a separate envelope before submitting the Examination Form. The words "Registration Form" must be written on top of the envelope. The retained candidates must first pass the Selection Test from his erstwhile school and then send the Examination Form to the Board.
4. Irregular Examinees :-
(a) Irregular candidates are to take the SSC Examination, 1982, at the approved Centres of this Board after coming through the Selection Tests.
(b) The Blind, Teacher, Armed Forces, BDR and Police candidates do not have to take the Selection Test. These candidates must send their Examination Forms via the Examination Centres as approved by the Board for taking the SSC Examination of 1982. (Their Examination Forms shall be rejected if these are sent to the Board directly.)
(c) All Irregular candidates of 1982 must apply to the Headmaster of the Board-approved schools at the district or sub-divisional Sadars for their Enlistment by 31 October 1981.
(d) Teacher-candidates and Armed Forces, B.D.R., Police candidates must enclose with their Examination Forms Certificates to be obtained from the District Subdivisional Education Officer and his Commanding Officer respectively to the effect that the candidate concerned has put in 3 (three) years' and one year's continuous service respectively.

- (e) The irregular candidates can sit for examinations only in the Humanities and Commerce Groups.
- (f) The blind examinees are to select their Script-Writers from amongst the students of class VIII and two (2) copies of photograph of the selected students must be sent to the Education Board, via the Headmaster of the School, for obtaining the Board's Permission.
5. The names of the Centres for Selection Test for the Irregular candidates and for sending the Examination Forms of the Armed Forces, BDR, Police and the blind and the teacher candidates are as follows :-

Pabna district :- (a) Pabna Zilla School (b) Sirajganj B.L. Govt. High School.
Bogra district :- (a) Bogra Zilla School (b) Joypurhat Govt. R.B. High School.
Rangpur district :- (a) Rangpur Zilla School (b) Gaibandha Govt. Boys' High School (c) Kurigram Govt. High School (d) Nilphamari Govt. High School.
Dinajpur district :- (a) Dinajpur Zilla School (b) Thakurgaon Govt. High School.

(d) Registration and Enrolment fees for Irregular candidates (for each person) Tk. 40.00
(e) Retention fees (per person) Tk. 20.00
(f) Permission fee for Division Development Examinees (per person) Tk. 30.00
(g) Work Experience (Eradication of Illiteracy) fees (for each person) Tk. 5.00
(h) Late fees (for each person) Tk. 15.00
(i) Selection Exam fees for Irregular candidates (per person) (To be deposited with Headmaster of the selected centre) Tk. 15.00
(j) Preparation fees (those irregular candidates who do not have to take the Selection Test. To be deposited with the selected Headmaster) Tk. 10.00
(k) Examination centre change fees (for each) Tk. 100.00
(l) Inter Board Examination centre change fees (for each) Tk. 200.00
(m) Centre fee for each candidate (those who do not have Practical Test) Tk. 15.00
(n) Centre fee for each candidate (those who have Practical Test in one Subject) Tk. 20.00
(o) Centre fee for each candidate (those who have Practical Test in more than one Subject) Tk. 25.00
7. (a) Work Experience (Eradication of Illiteracy — Mass Education) Examination shall be held for 50 (fifty) marks and it shall be deemed as One half Paper.
(b) Candidates interested in Divisional Development may take the Division Development Examination only once before passing the HSC Examination and within 2 (two) years of passing the SSC Examination. They shall be treated as Irregular candidates and they do not have to register afresh.
