## Notice for Admission in Medical College

Applications are invited in prescribed form for admission into the 1st Year M.B.B.S. Class of the Medical Colleges for the session 1985-86.

2. The candidates must have passed the S.S.C. Examination in any group & H.S.C. Examination having Physics, Chemistry & Biology or its equivalent recognised by the Board of the Intermediate & Secondary Education or Universities of Bangladesh and must have obtained at least 60% marks (without grace, extra & deduction for irregularity as per para 7 and without any 3rd division) in the combined total of S.S.C. & H.S.C. results.
- The tribal candidates, who have passed the S.S.C. and H.S.C. Examination both at least in the 2nd division are eligible to apply.
3. The candidates must be citizens of Bangladesh except for the 50 (fifty) seats reserved for foreign students.
4. 12 (Twelve) seats will be kept reserved for tribal candidates of Chittagong Hill Tracts and Bandarban district. 2 (Two) seats will be reserved for tribal candidates of Sylhet district and 2 (Two) for those of other districts. Total seats in Medical College are 1200. Excluding reserved seats for foreign students and tribal candidates.
5. 50% of the seats will be filled up on the basis of National merit irrespective of sex. Rest of the seats shall be distributed among the old districts on the basis of population. 30% of those seats for district quota will be filled by female candidates, if available. If not available, the vacant seats shall go to the male students of the particular district on the basis of merit amongst themselves. If the required number of male students of any district are not available the vacant seats will be filled up by female candidates of that particular district on the basis of merit amongst themselves. The number of female students in any Medical College will ordinarily be kept within 30% of the total seats in the College.
6. Admission will be solely on the basis of merit as reflected by the total of marks (without grace mark, extra mark and after deduction of marks for irregularity) of S.S.C. and H.S.C. Examinations and marks obtained in the Viva and Written examinations. The "District Quota" seats will be filled up on the basis of merit within the district. The territorial jurisdiction of the old district will be considered as the basis for determination of district quota seats.
7. Candidates who passed H.S.C. examination in the current calendar year i.e. 1985 and S.S.C. Examination in 1983 will be considered as regular. A candidate who has passed S.S.C. Examination prior to 1983 will be considered as irregular and for each year of irregularity 25 marks will be deducted. Improvement examination will be considered as irregular, but 10 marks will be deducted for this irregularity. Deduction of marks for irregularity/improvement will be applicable to S.S.C. Examination only.
8. The choice of College will be decided on the basis of merit and preference given by the candidate.
9. Prescribed application forms of 2 colours, white and green, for use by the male and female candidates respectively, will be available in the offices of all the Medical Colleges of Bangladesh, on payment of Tk. 10/- (Taka ten) only as registration fee, in cash.
10. Applications, complete in all respects, will be received by the Principal of Medical College from which the application forms were supplied. At the time of submission of application, Tk. 80/00 (Taka eighty) only will be payable in cash as centre fee.
11. A full list of all eligible candidates showing the Colleges where they will appear in Viva-voce and written examinations will be available in the offices of Medical Colleges, where they will submit the applications.
12. Selected candidates will be admitted in the Medical Colleges on the basis of merit and preference irrespective of the College in which his/her viva-voce and Written examinations were taken. The results of Viva-voce examination will be published on the same day.
13. For the sake of convenience of the candidates, the written and Viva-voce tests will be held in the respective Medical College, where they will apply for admission. In order to maintain uniformity in marking, the scripts will be coded and examined centrally at Dhaka. The applicants not appearing in Viva or Written test shall be disqualified.
14. Further information regarding admission matters will be available in the offices of Medical Colleges.
15. No prayer for change of district/change of choice of Medical College & change of district for reserved seat will be entertained.

16. Final selection of candidates is subject to medical fitness as decided by a Medical Board.

17. All certificates/documents in original are to be submitted at the time of Viva/Voice Admission, failing which the applicant's candidature will be rejected.

18. Completed application in prescribed form will be submitted in the Medical College from where the form was collected. All applications must be accompanied by the following documents :-

- a) Attested/Photostat copy of S.S.C. Examination certificate.
- b) Attested/Photostat copy of the certificate of passing H.S.C. Examination, from the Principal of the College from which he/she passed the H.S.C. Examination.
- c) Attested/Photostat copies of S.S.C. & H.S.C. mark sheets.
- d) Attested copy of certificate from the head of the institution, in which the applicant studied last regarding his/her character, personality career and extra curricular activities and permanent home district (Old).
- e) Certificate of character from a Class-I Gazetted officer.
- f) Attested copy of Nationality certificate.
- g) Attested copy of certificate from a Class-I Gazetted Officer/Chairman of Union Council regarding the annual income of father/guardian or an attested copy of the income tax certificate & permanent home district (Old).
- h) Tribal candidates shall have to furnish a certificate (In original) from the Deputy Commissioner of the district concerned and also from the concerned tribal chief testifying that he/she is a tribal candidate of that district. These certificates must be submitted in the prescribed forms available in the offices of the Principal of the Medical Colleges.
- i) The candidates of Chittagong Hill Tracts and Bandarban district claiming seats from district quota shall be required to furnish a certificate (in original) from the Deputy Commissioner of those districts stating that the applicants are permanent residents of Chittagong Hill Tracts or Bandarban district, whichever the case may be.
- j) 3 (Three) Attested copies of recent passport size Photograph.
- k) Acknowledgement slips showing the payment of Tk. 10/- (Taka ten) only as registration fee and Tk. 80/- (Taka eighty) only as centre fee.

19. Applications received after the expiry of the last date and time and incomplete applications will not be considered.

20. All informations regarding admission will be found on the Notice Board of the Medical Colleges. No correspondence in connection with admission will be made at the address of the candidate.

21. Because of the scarcity of seats in the hostel, students admitted in the Medical Colleges will have to arrange their own accommodation.

22. No migration will be allowed from one Medical College to another and no application in this regard will be entertained.

23. After passing the final M.B.B.S. Examinations, the newly passed doctors will have to take internship training in the Hospital of the Medical College from which they passed. They will not be allowed transfer to any other Medical College Hospital for the purpose of internship training. After the completion of internship there is no guarantee of Government Service.

24. After the last date of admission the vacant seats, if there be any, will be filled up within one month. But before filling up the vacant seats, the position of already admitted students will be re-adjusted within the National merit and district quota seats and also their placement in Medical Colleges will re-adjusted according to merit & option of College resulting in automatic migration of a good number of students from one Medical College to the other. This process causes dislocation of teaching programme of the Institutions and also lot of inconvenience to the students concerned. Considering these factors, it is not possible to admit students again & again in the same session. Despite this fact, it has been decided in the admission policy that the vacant seats will be filled up only once.

25. The last date for receipt of applications by the offices of the Principals of Medical Colleges is the 30th November, 1985 upto 2.00 P.M.

26. The written test will be held on 6.12.85 at 9 A.M. Viva-voce Examination will commence on & from 10.12.85 at 8 A.M.
