Policy for Admission in the Medical Assistant Training Schools for the Session '86-87

In all 240 students will be admitted in to the 8 Medical Assistant Training Schools at Faridpur, Kushtia, Bogra, Noakhali, Tangail, Comilla, Serajgonj & Bagerhat for the session 1986-87. The 240 students will be selected on the basis of district quota (old) (excluding reserved seats) and 13 reserved seats for Tribal students will be selected from amongst the tribal candidates. The District quota (old) is determined on the basis of population. 20% seats in the district quota (old) is reserved for female candidate and 25% seats for departmental candidates, but if the required number of eligible female and departmental candidates are not available, the vacant seats will be filled up by male general candidates of the same district.

2. The number of seats available in different schools and the district attached to them for the purpose of receiving applications are shown below:—

Candidates of the attached districts will apply to the Principal of the respective Schools. Application form will be obtained from the Principal, on payment of Taka 10/- each (Not refundable). The application form can be obtained by post if a Postal Order of Taka 10/- and a self addressed stamped envelope are sent to the Principal of the respective School. Incomplete application will be rejected. Duly completed application form by the candidate himself should be submitted to the respective Principals not later than 20-11-1986.

3. To be eligible to apply a candidate must have the following requisite qualification:—

a) Minimum academic qualification: S.S.C./equivalent 2nd Division in case of Departmental candidate qualification: S.S.C./equivalent.

b) Maximum age on 1.7.1986 : 22 years relaxable upto 30 years for candidates who are serving as FWW, GHA, AHI, FWA, FPA, FWV and LHV under the Ministry of Health & Family Planning for at least 3 years for getting deputation.

4) The application will have to be accompanied with the attested copies of:—

- S.S.C. mark sheet issued by the board concerned.
- Certificate & Testimonials from the head of the School/Institute from where he/she passed the S.S.C. examination.
- Certificate of residence from local Union Council Chairman.
- Certificate from the local Upazila Health & Family Planning Officer/respective controlling officers regarding serving as FWW, GHA, AHI, FWA, FPA, FWV and LHV in case of Department candidate.
- Two copies of passport sized photographs of the applicant attested by a gazetted officer.
- Other testimonials if any.
- No affidavit in respect of age will be allowed for the purpose of selection.

Thirteen seats are reserved for bonafide tribal students. The tribal candidates shall have to submit alongwith their application, the original copies of a certificates signed by their respective Deputy Commissioner of the district, certifying tribal origin of the candidates including the name of the tribes.

6. Candidates will be selected for provisional admission on the basis of merit as manifested by the total marks obtained in the S.S.C. examination by the candidates plus an interview and viva-voce test to examine the aptitude of the Boys/Girls particularly to serve in the rural areas. For candidates who have passed S.S.C. before 1986 for each year of irregularity 10 marks from the total marks will be deducted. The deduction for irregularity will not be applicable for candidates who are serving as FWW, GHA, AHI, FWA, FPA, FWV and LHV under the Ministry of Health & Family Planning. The departmental candidates should apply through proper channel. Candidates of the different district will be selected for admission in the different Schools. The vacant seats will be filled up from the candidates of the merit list.

7. Admission of selected candidates shall be subjected to Medical Fitness as determined by Medical Boards. Selected candidates are to appear before a Medical Board at the School for which they have been selected. No T.A. or D.A. will be allowed for appearing before the Medical Board.

8. Selected candidates will have to submit their original marksheets at the time of provisional admission. The mark sheets will be varified from the respective Boards by the Principal of the School where the students is provisionally admitted. The charges required by the Board for such verification will have to be borne by the student and will be realised at the time of provisional admission or later. After the provisional admission if it is detected that a candidate had submitted any false/forged or fictitious mark sheet or certificate by the false statement in his application form, his provisional selection and admission will be cancelled forthwith and he will be expelled from the school where he is admitted.

Besides, for giving any false statement or for submitting false marksheet/ certificate, appropriate legal action may also be taken.

9. A waiting list will be prepared against each district & the vacant seats will be filled up from the waiting list of that District after one month of last date of admission. No further waiting list will be prepared.

10. The duration of the course shall be for a period of three years of institutional and field studies. During the course of 3 years of institutional studies, the student will have to pay Taka 20/- per month as tuition fees. There are limited number of seats in the hostel and student have to pay Taka 10/- per month as seat rent if a hostel seat is provided. Electric and other charges would be fixed by the Hostel Superintendent in consultation with the Principal, Medical Assistant Training School.

The government does not take responsibilities of providing employment to all the qualified Medical Assistants.
