## National Science and Technology Fellowship 1992-93

Applications in prescribed form are invited for National Science and Technology (NST) Fellowship for the F/Y 1992-93. The following three categories of Fellowships will be offered for applied research work in their respective field:

1. Ordinary Fellowship: (a) Taka 1250/- per month (consolidated) for student-fellows engaged in part-time research and (b) Taka 1650/- (consolidated) for whole time research fellows. Minimum academic qualification: M.Sc/B.Sc. Engineering/M.B.B.S./B.Sc. (Hons) in Agriculture/Animal Husbandry/Fishery/Agri. Engineering/Agricultural Economics/Forestry and M.Sc in Agriculture or equivalent degree from any recognised University having at least second class academic career all through but relaxable in case of candidates having 1st class in the graduate/post graduate level. Age limit: 30 years.

Persons trained from vocational Institutes/Diploma holders from any Technical Institutes/Technicians having technical knowledge and experience and interested in research and development of appropriate technology/indigenous technology are also eligible for fellowship. Age limit: 30 years.

2. Senior Fellowship: Taka 2800-3700/- per month (consolidated) according to qualification and experience. Persons with the minimum qualification as that for ordinary fellowship and having 5 years research experience or Ph.D. degree are eligible to apply. Age limit: 30 years.

3. Expert Fellowship: Taka 4,750/- per month (consolidated). Candidates with minimum qualification as that for senior fellowship and having at least 10 years professional experience in any university or research organisation as research scientists or technologists either at home or abroad are eligible to apply. Age limit: 45 years.

The candidates who are in regular services in Govt/Semi-Govt/Non-Govt/Autonomous organisations are not eligible for NST fellowship. In special cases & renowned personnel age limit may be relaxed.

### Field of Research under NST fellowship programme

Considering the research programmes of the sponsoring agencies and the overall national requirement, production and service oriented research projects for technology development priority may be given in the field of (1) Physical, Engineering and Environmental Sciences; (2) Biological and Medical Sciences; (3) Food and Agricultural Science; (4) Science and Technology Planning and Evaluation Research; (5) Appropriate Technology/Development of Indigenous Technology.

Specimen of application form, sponsorship certificate and fellowship rules can be obtained directly from the Science & Technology Division or office of the Director, BANSDOC Building, Science Laboratory campus, Mirpur Road, Dhaka or Registrar, Rajshahi, Chittagong & Khulna University/Registrar, Bangladesh Agricultural University, Mymensingh; through personal contact or by sending large size self addressed envelope with 4/00 Tk. postage stamp.

Application in prescribed form along with two copies of passport size photographs, attested copies of academic records, marksheets and sponsorship certificate should reach the office of the undersigned on or before the 15th December, 1991.
